Where: Villanova Preparatory School, Ojai, CA

Purpose: To motivate and assist confirmed youth in sharing and living their Sacrament of Confirmation by: developing leadership and witnessing skills, deepening their faith and love for the Lord Jesus, training youth as peer ministers to serve other youth.

Cost: \$300 includes tuition, room and board, t-shirt, supplies. Checks are payable to “Villanova Preparatory School”

What To Bring: sleeping bag (a lighter blanket and/or top sheet is suggested, but optional), pillow, casual clothes (jeans, shorts, long and short sleeved t-shirts sweatshirts or light jacket), water bottle (HydroFlask, etc), toiletries, towel, tennis shoes, shower shoes, sunscreen, prescription medications. Bathing suit (girls: must be one piece full coverage, boys: must be trunks, no speedos), extra towel for pool. Optional: musical instruments, camera, flashlight, journal, money (small bills) for snack shop.

Do Not Bring: Electronic devices: iPads or other tablets, computers, etc. (If you bring these items they will be collected by the staff.) Cell phones may be used for emergencies only, and will be collected by staff and held until the end of the week if used without permission. Smoking is not permitted, no illegal drug use. Weapons of any kind are not allowed on property. Do not bring valuables.

Medication: If your child will be sent with medication, it must be turned into our camp nurse and will be distributed by the nurse when needed. All medication must be accompanied by a Medication Release Form. Please email fwilliams@villianovaprep.org for a copy of the form.

Process: All registration forms are due before May 15, 2023, all registration forms must be completed online at www.VillanovaPrep.org/SAW. The registration fee is \$300.00, no refunds will be issued after July 1st. Fees and permissions slips should be mailed in together to:

PERSONAL IMAGE CONSENT AND RELEASE AGREEMENT

1. I hereby acknowledge that VPS reserves all of its copyright and other rights and is the sole owner of the copyright, title and other interests in all photographs, original film, prints, negatives, artwork, video recordings, audio recordings, soundtracks, internet websites and any other media, whether now existing or developed in the future, produced by or for VPS utilizing the Images, and is the sole owner of any sales, revenues and profits derived therefrom.

3. I hereby assign all right, title and interest in and to the Images to VPS, free of any claims whatsoever by me, my minor child or any other person or entity. I agree to assist and cooperate with VPS, at VPS's expense, in securing and perfecting title to the Images. I further hereby forever release and hold harmless VPS, its photographer, video or movie makers, agents, representatives, licensees, successors and assigns from any and all causes of action, claims, liabilities and demands of any sort I ever had, now have or may have, or which my child, heirs, executors, administrators or assigns now have or may ever have, in relation to the Images. This grant, conveyance and release shall inure to the benefit of VPS, its representatives, licensees, agents, successors and assigns.

4. I hereby waive any right I, my child or our successors, heirs, agents or assigns might otherwise have (i) to inspect or approve any advertising or other materials produced utilizing the Images, or to approve, disapprove or limit any use to which the Images may be put, (ii) to assert any claim against VPS, based upon or arising out of any alleged or actual misrepresentation or defamation of my child, his or her character or person, or other damage to me, him or her, due to distortion, alteration, optical illusion or faulty reproduction of the Images, and hereby release and discharge VPS from any liability relating to or arising out of any of the foregoing, and (iii) to assert any claim for compensation for use of the Images.

I, the undersigned, parent/legal guardian of the above mentioned participant, a minor, do hereby authorize the Headmaster or other designated representatives including the Assistant Headmasters, administrators, faculty, staff and athletic coaches of Villanova Preparatory School, Ojai, California, ("Villanova") as agents of the undersigned to consent to any x-ray examination, anesthetic, medical or surgical diagnosis or treatment and hospital care, which is deemed advisable by and is to be rendered under the general or special supervision of any physician or surgeon licensed under the provisions of the California Medical Practice Act, whether such diagnosis or treatment is rendered at the office of the said physician, at a hospital or any location supervised by Villanova personnel. This authorization also applies to dental care and eye care provided by licensed persons, as well as, to providing first-aid on Villanova's campus, field trips, or in connection with any other Villanova sponsored activity.

It is understood that this authorization is given in advance of any specific diagnosis, treatment or hospital care being required but is given to provide authority and power on the part of our aforesaid agent(s) to give specific consent to any and all such diagnosis, treatment or hospital care, which the aforementioned physician in the exercise of his/her best judgment may deem advisable; and neither said agent or any organization involved, including without limitation Villanova Preparatory School, assumes liability or any financial responsibility for exercising the power given by this authorization.

This authorization is given pursuant to the provisions of Section 6901-6910 of the Family Code of California and shall remain in effect until revoked in writing and delivered to said agent(s). All minors attending must have health and accident insurance coverage during the time of camp.
